In the event a lawsuit is commenced, and Purchaser/Applicant should want to pay off the amount in full prior to judgment, Tech CCTV shall, in addition to principal and interest, be entitled to attorney's fees and costs of suit incurred to that point.

In the event a check is given on payment on account or in connection with any purchase, whether or not a sale or credit, and such check, upon deposit or negotiation, is not promptly honored by the bank upon which drawn, the provisions of Paragraphs 2 and 4 shall be applicable in regard to the indebtedness represented by the check.
